We have attempted to answer some commonly asked questions that members may have. If you have any other questions, do not hesitate to contact us for further clarification.

1 What was the process that led to the decision to amalgamate?

Upon request from both retails, a feasibility study was prepared by FCL Region Finance, and subsequent meetings between the Co-ops were planned to discuss the results. The feasibility study was discussed with the Boards showing positive results, and a decision was made by each Board to proceed to a membership vote.

2 What will the name of the Co-op be following amalgamation?

Upon amalgamation, the newly formed Co-op would be named Evergreen Co-operative Association. Each location could still keep its own identity (Rimbey, Rocky Mountain House).

3 Will I be able to keep my existing Co-op number?

Membership lists will be merged, and a prefix will be added to the Rimbey Co-op member numbers; e.g., 135 will become 80135, member 1135 will become 81135 and so on. In some instances, there may be individuals who hold membership in more than one Co-op. In this case, the member's equity would be combined into one number. Membership numbers in Rocky Mountain House will not change.

4 Will there be any lost jobs because of the amalgamation?

No. The feasibility is based on no jobs being lost in the process. There would, however be some restructuring and changes in responsibilities within the departments. All employees would be employed within the new Co-op or placed within the Co-operative Retailing System.

5 Will I lose my equity in either Rimbey or Rocky Mountain House Co-ops?

No. Any equity that has accumulated in either Co-op will be carried forward to the new Co-op.

6 Does the amalgamation benefit members from both Co-ops?

Yes, both Co-ops will benefit. Combining into one Co-op will strengthen both Co-ops and produce annual cost savings in excess of \$463,716. The new Co-op would be in a position to offer a wider range of products and services in the future as a result of the amalgamation.

7 Will my cash refund from my patronage change?

The feasibility study shows that the amalgamated Co-op will be in a strong financial position to continue our emphasis on our Equity and Cash Back program to our members. Equity programs from both retails were strong prior to an amalgamation and would be expected to continue following the amalgamation.

8 What is the timeline for the amalgamation?

We will be having two special membership vote meetings: April 26th in Rimbey and April 27th in Rocky Mountain House. Following approval of the proposed amalgamation motion, we would start amalgamation procedures over the next few months with the intent of finalization on December 1, 2017.
